Power Trading Results in December 2018

In December 2018, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 66.4 TWh. The share of Order Book traded power was 28.5 TWh which includes 1.3 TWh from German Power.

Electricity Certificates Trading Results in December 2018

In December 2018 the total volume of traded and cleared Electricity Certificates was 1.54 million EI-Certs. The share of Order Book traded EI-Certs was 0.02 million EI-Certs.

Carbon Trading Results in December 2018

In December 2018 the total volume of traded and cleared EUAs was 0.13 million tonnes.
